**M.Sc. Forestry Admission Notification – 2023**

**No.11/FCRI (TS)/M.Sc.Forestry/Admissions/2023**

Applications are invited for admission into the M.Sc. Forestry Two-year post-graduate degree programme (of four semesters) in following specialisations for the academic year 2023-24:

- (i) M.Sc. Forestry (**Silviculture & Agroforestry**) – **Two (2) seats**
- (ii) M.Sc. Forestry (**Forest Biology & Tree Improvement**) – **Two (2) seats**
- (iii) M.Sc. Forestry (**Forest Resource Management**) – **Eleven (11) seats**

**Mode of Admissions and eligibility criteria:**

- (i) The B.Sc. (Hons.) Forestry candidates with a minimum OGPA of 7.0 out of 10.0 are eligible to apply. However, for SC/ST candidates, the minimum OGPA required is 6.5 out of 10.0.
- (ii) The candidates should have appeared and qualified in the ICAR-AIEEA-PG entrance examination 2023.
- (iii) Weightage shall be 50:50 for performance in the ICAR-AIEEA-PG entrance examination and academic record at Under Graduate level.
- (iv) In case of tie, to break the tie, the marks in ICAR-AIEEA-PG entrance, the academic record at UG level and date birth will be considered in sequence.
- (v) The statutory reservations will be followed as per the guidelines issued by the Government of Telangana.

**Procedure for applying:**

- Prescribed application form has to be filled online at the college website <https://www.fcrits.in/> and by uploading the required documents from 15-10-2023 to 27.10.2023.
- **Application fee to be paid online:** Rs. 1000/- for SC / ST / PH candidates and Rs. 2000/- for others should be paid on or before 27-10-2023.

**General:**

- (i) Students who join M.Sc. Forestry are not allowed to pursue any other degree/ diploma concurrently.
- (ii) The admission into M.Sc. Forestry is provisional and liable for cancellation subsequently if found repugnant to rule/ regulations or invalid by reason of incorrect/ false information furnished at the time of admission. Besides action will be taken under relevant Act/ Rules/ Guidelines.
- (iii) Hostel accommodation is provided subject to availability and based on the merit of student.
